- Accounts more than 30 days in arrears will be subject to a \$25 administrative fee and loss of playing privileges.
- All Players over the age of 7 will be given a non-refundable Key Fob for obtaining access into the club. Lost fobs will be replaced at a cost of \$20 plus HST
- Academy Withdrawals: Notice of withdrawal must be made in writing (email is acceptable) to Gary Muller. All withdrawals will be charged a 30 day penalty effective from the date of receipt of official notification. Please do not tell a pro during academy hours and expect them to relay the information.
- **Summer Play Pass.** Academy players who participate for 3 or more days per week for at least 6 months of the program and are still enrolled in June 2011 will receive an ORC Summer Play Pass. The Summer Play Pass is a \$175 value that includes all outdoor court fees for the months of May and September and indoor/outdoor court fees June-August.
